### What are the **Praxis™** tests? Which tests should I take?

**The Praxis Series™** tests are comprised of the **Praxis I® Pre-Professional Skills Tests (PPST®)**, which are designed to measure basic skills in reading, writing, and mathematics; and the **Praxis II® Subject Assessments**, which measure knowledge of specific subjects that K–12 educators will teach, as well as general and subject-specific teaching skills and knowledge. Colleges and universities use the **PPST** tests to evaluate individuals for entry into teacher education programs. State education agencies use the **PPST** tests for teacher licensure and certification. The assessments are generally taken early in your college career. **Praxis II Subject Assessments** are usually taken by individuals entering the teaching profession as part of the teacher licensing and certification process required by many states. Some professional associations and organizations require these tests as one criterion for professional licensing decisions.

Testing requirements for all states that use **Praxis** tests for licensure can be found on the **Praxis** website at **www.ets.org/praxis/staterequirements**. Please note, however, that licensure requirements are often complex and change frequently; therefore, we urge all candidates to check directly with the state or agency with which they are seeking licensure for complete details.

### How do I register?

- **Register Online** for paper-based **PPST** and **Praxis II Subject Assessments** using a credit or debit card (American Express®, Discover®, JCB®, MasterCard®, and VISA®). Note: Any debit/check card branded with one of the five accepted credit card logos can be processed. ETS reserves the right to add or remove online payment methods at its own discretion and without notice. To register and pay by check, money order, or U.S. Postal Service money order, download and complete the Paper-Based Test Registration Form and submit it to the address on the form with payment. The list of information required for registration can be found on the **Praxis** website.
- To register for a computer-based **PPST** using a credit or debit card, call Prometric Candidate Services at 1-800-853-6773 or call your test center directly. A list of test centers is available on the **Praxis** website. To register and pay by check, money order, or U.S. Postal Service money order, complete the CBT Authorization Voucher Request form available on the website and submit it to the address on the form with payment.

**Note:** Some states require a social security number (SSN) in order to process teacher certification paperwork. Check your state's requirements page at **www.ets.org/praxis/staterequirements** to see if your state requires a SSN with your test score reports. ETS does not require your SSN for its own purposes, but will submit it to your state agency with your test results. Failure to provide your SSN could delay your state's processing of your certification application.

### Emergency Registration

Emergency registration is available for test takers who need to register but have missed the regular and late registration deadlines. This service will guarantee test takers a seat at the test center. Please see the **Praxis** website for restrictions, fees, and more information. ## What accommodations are available for nonstandard test takers?

**Primary Language Is Not English (PLNE) Testing.** If your primary language is not English, you may be eligible for PLNE accommodations, which allow candidates additional testing time. PLNE testing is not offered for language tests and is available only at selected centers and on selected dates.

**Monday Testing.** If religious convictions preclude you from testing on Saturday, or if you are a member of the U.S. armed forces and you have duties that prevent you from testing on Saturday, you may test on a Monday.

**Test Takers With Disabilities.** ETS is committed to serving test takers with disabilities by providing services and reasonable accommodations that are appropriate given the purpose of the test. Nonstandard testing accommodations are available for test takers who meet ETS requirements.

## What should I know about ID requirements?

Valid identification with **name**, **signature**, and **photograph** is required for admission to a test center. ID requirements are strictly enforced. When scheduling your test, you must use exactly the same name as shown on the primary identification document that you will present at the test center. If your primary ID is missing either a photo or a signature, you must present a supplemental ID in addition to your primary ID. ## What if I need to cancel or reschedule my test?

**Computer-based Test.** Call the appropriate test center or Prometric Candidate Services **no later than three full days** prior to your appointment. You can request a refund by submitting a Refund Request Form to ETS. If you do not cancel within the appropriate time frame, your test fee will be forfeited.

**Paper-based Test.** To cancel and request a refund, submit a Refund Request Form to ETS. The form must be received **no later than three full days** prior to your test date. Please note that registration fees are nonrefundable.

## When will I receive my scores?

**Computer-based (CBT) Praxis I Tests.** You can view unofficial reading and mathematics scores at the test center; however, because of the essay scoring process, you cannot view your writing score at that time. Official scores will be sent to you and your designated score recipients 10–15 days after you take the test.

**Paper-based (PBT) Praxis Tests.** If you register online, your score report will be available by web on the evening that score reports are being mailed. Score reports for individuals who register by paper or telephone reregistration will be mailed approximately four weeks after the test date. If you wish to obtain your scores earlier, you may use the Scores by Phone service. More information about Scores by Phone is available on the **Praxis** website.

**Additional Score Reports (ASRs).** ASRs are available for a fee. Complete your request online or download and complete the ASR request form located on the **Praxis** website.

You may cancel your scores on the computer-based test at the end of the exam by choosing the Cancel option instead of the View Your Scores option. If you take a paper-based version of the test and wish to cancel your scores, download and complete the Request for Score Cancellation form on the **Praxis** website. The form must be received by ETS no later than seven days after your test date. You will not receive a refund if you choose to cancel your score. Canceled scores cannot be reinstated.
